For patients using opiates, it extends to about 14 days (about 2 weeks). Individuals using high doses of methadone should anticipate a longer detoxification period. The program employs Suboxone as part of the opiate detoxification protocol. Smoking is permitted during designated outdoor breaks but is prohibited on hospital property.
